RESOLUTION NO. 2013-30

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) advertised the Invitation to Bid for the Supply and Delivery of Combat Clothing and Individual Equipment (CCEI) for Special CAFGU Active Auxiliaries (SCAA) in one (1) newspaper of general nationwide circulation and posted the same in the BCDA website, the DBM Philippine Government Electronic Procurement System (PhilGEPS) website and in a conspicuous place reserved for the purpose in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, no bids were received by the BAC in time for the Bid Opening on 12 August 2013;

WHEREAS, on 12 August 2013, the BAC members conducted a meeting for the purpose of mandatory review of the terms and conditions in the Terms of Reference (TOR) of the intended procurement;


