**BAC FOR GOODS RESOLUTION DECLARING FAILURE OF BIDDING
FOR THE SUPPLY AND DELIVERY OF BCDA CORPORATE-WIDE GIVEAWAYS**

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) advertised the Invitation to Bid for the Supply and Delivery of BCDA Corporate-Wide Giveaways in the BCDA website, the DBM Philippine Government Electronic Procurement System (PhilGEPS) website and in a conspicuous place reserved for the purpose, in the premises of BCDA, continuously for seven (7) calendar days;

WHEREAS, in response to the Invitation to Bid, three (3) prospective bidders purchased the bidding documents namely:

1. CYN Trading & Services, Inc.
2. NJR General Merchandising, Inc.
3. Mitsui Trading Philippines Ltd. Co.

WHEREAS, on 18 November 2013, only two prospective bidders submitted their bid proposals, namely:

WHEREAS, Item 9 of the Invitation to Bid (IB) and Clause 21 of the Bid Data Sheet (BDS), clearly specify that bidders are required to submit their bid at BCDA Central Receiving and Releasing Area (CRRA) on or before **18 November 2013, 9:00 AM Philippine Standard Time (PST)**;

WHEREAS, Mitsui Trading Philippines Ltd. Co. and NJR General Merchandising, Inc. submitted their bids at 9:11 AM and 9:18 AM, respectively;

WHEREAS, Clause 21 of the Instructions to Bidders (ITB) likewise clearly provides that:

*"Any bid submitted after the deadline for submission and receipt of bids prescribed by the Procuring Entity, pursuant to ITB Clause 21, shall be declared **"Late"** and shall not be accepted by the Procuring Entity."*

NOW, THEREFORE, We, the Members of the BAC for Goods, hereby RESOLVE, as it is hereby RESOLVED, to:

1. Recommend the declaration of **FAILURE OF BIDDING** for the Supply and Delivery of BCDA Corporate-Wide Giveaways.
2. Request authority to proceed with the re-bidding for the Supply and Delivery of BCDA Corporate-Wide Giveaways.
